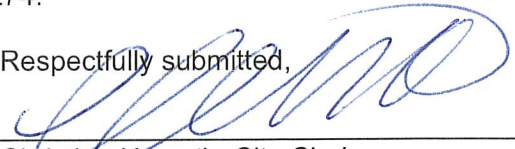

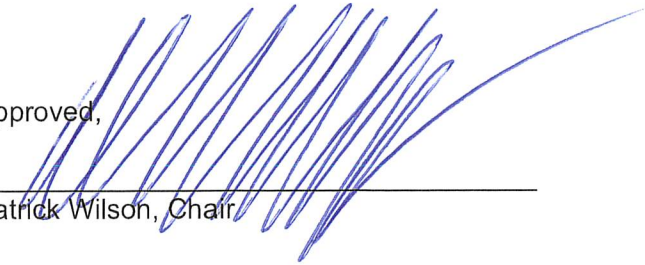
14. ADJOURNMENT: 9:06 A.M.
